I-We agree to the following terms and conditions.

1. I will not hold Canoe Music City, Inc. or their employees responsible for any accident, injury or loss while operating canoes or kayaks on land or water or being transported to or from river.
2. I will not hold Canoe Music City, Inc. or employees responsible for any accident, injury or loss to members of my canoeing or kayaking party including minors.
3. Members of my canoe or kayak party under 13 years will wear a (PFD) Personal Flotation Device while on the river.
4. No Alcohol.
5. I will obey park rules and regulations while on the river.
6. I will not hold Canoe Music City, Inc. or their employees responsible for accidents, injury, loss, theft or personal property left on premises of Canoe Music City, Inc., or for shuttled vehicle services.
7. I agree to be responsible for lost, stolen, damaged canoes, kayaks, paddles, life vests during the rental period, and agree to pay for loss per schedule below.
8. I have found the canoe and kayak to be in good condition and sea worthy and agree to return to Canoe Music City, Inc. or employees in same general condition.
9. All canoe and kayak trips must be finished by 6 PM.

10. I understand that if I step outside my boat onto any river bank or gravel bar I am subject to Tennessee trespass laws.
 11. Canoe Music City, Inc. closes at 6 PM and may charge a \$20 per hour late fee per canoe or kayak.
 12. I agree to pay any and all legal fees incurred resulting from the operation of rented equipment of Canoe Music City, Inc. equipment.
 13. I agree to remove all debris from Canoe or Kayak and dispose of properly.
 14. Canoe Music City, Inc. is not responsible for weather or river conditions that may prevent the completion of a trip.
 15. I expressly acknowledge that naturally occurring disease processes (including but not limited to the currently wide-spread coronavirus) occur in all environments in which this activity takes place. I acknowledge that, while Canoe Music City, Inc., has taken reasonable measures to avoid contact, transmittal or contamination of the virus between people (including guest/participants, employees, and other 3rd parties) that it is ultimately my responsibility to safeguard myself and others.
- I understand and agree that, if I choose to participate in the activity, Canoe Music, Inc., cannot and will not have any legal liabilities toward me if I contract the virus.
